The Journal of the Castilla y León, Cantabria and La Rioja Otorhinolaryngology Society is an open access electronic publication with global scope and distribution for the publication of articles on Otolaryngology and related clinical and experimental areas (basic science, hearing, language, management).

The contents are intended for specialists in otolaryngology and related medical disciplines.

The texts are available in open access on the journal's website (http://www.revistaorl.com) and the DIALNET and DOAJ e-Journals repositories.

The journal is included in the Latindex catalogue.

Content

At the end of the text the author will summarize/comment the most important aspects of the article and may add other bibliographical citations recommended in relation to the subject of the annotated article.		
Letter to the Editor	Brief commentary on an article published in the journal. It includes the annotated article in the bibliography.		
Supplement	To be published as a supplement: Abstracts of papers from the annual conference, posters, annotated articles, monographs, books, dissertations, guidelines, protocols and manuals. The Editorial Committee may delegate the production of documents to an author or working group to be published as a supplement.		

Manuscript submission

Manuscripts for publication must be sent by email to the Editor of The Journal of the Society of Otorhinolaryngology Castilla y León, Cantabria and La Rioja at:envíos@revistaorl.com.

Entries must be original and unpublished.

Entries must be submitted in Spanish.

In the email reference to the title of the article, a brief presentation of the author's interest in its publication and a statement that there is no conflict of interest should be made.

In the case of clinical trials documentation of approval by the Ethics Committee of the hospital or research centre is required.

Articles with photographs that include patients who could potentially be identified must be accompanied by express documentation that these images were obtained and are published with patient consent.

Manuscript requirements

- 1. Works must be original and unpublished, and not be sent simultaneously to other journals or be accepted for publication. In the event that they have been published this must be explicitly stated in the text and include the citation.
- 2. Length, number of figures and maximum tables allowed. There are no limits. However, the table shows some guidelines for authors:

- 3. In writing papers, authors can use as a guide Uniform Requirements for Manuscripts Submitted to Biomedical Journals (http://www.icmje.org) prepared by the Vancouver Group, available on the journal's website (www.revistaorl.com), from the NORMAS [Guidelines] tab).
- 4. Articles must be in the corresponding original Word format available online (www.revistaorl.com). Other formats will not be accepted.
- 5. The manuscript should be submitted in a single document with tables and figures inserted in the template in the space provided at the end for tables and figures. Do not send attachments.
- 6. The manuscript in Word must be accompanied by the completed checklist in Excel as indicated on the web site (SELF-ASSESSMENT DOCUMENT)
- 7. The Editorial Committee will decide the final classification of the article.

It is important to cite Spanish literature sources.

In case of related articles in The Journal of the Society of Otorhinolaryngology Castilla y León, Cantabria and La Rioja these references must be cited.

Bibliographic citations should reflect the Vancouver standards (Uniform Requirements for Manuscripts Submitted to Biomedical Journals) (http://www.icmje.org).

The name of the journal appears in abbreviated form, followed by the year, volume number and first and last page of article.

In the references section the number of each reference number must be followed by a period (e.g. 24.)

Abbreviations: Abbreviations can be used in the text. They must be defined in the text the first time they are mentioned. The abbreviations of units of measurement shall be as recommended in Rev Esp Cardiol. 2004;57:538-56.

Format of the text: Arial 12 point. The text must be written in lowercase avoiding paragraphs appearing only in uppercase.

Check lists: To facilitate the submission of manuscripts authors should send a check list from the journal available online in Excel format (<u>SELF-ASSESSMENT DOCUMENT</u>).

In addition, links are provided to the main checklists for each type of study as provided by the EQUATOR Network.

Processing manuscript

1. Receipt of manuscript.

Manuscripts are received by the editor of the journal via email.

Each manuscript is assigned a number to facilitate its identification during the evaluation process. The editor makes a first assessment of the formal characteristics of the work and may ask the authors to adjust the manuscript to meet the standards. If the manuscript does not meet the standards in successive versions it will be rejected by notifying the authors.

2. Peer review of the manuscript.

Anonymity is guaranteed throughout the evaluation process.

The anonymous manuscript is sent to two outside reviewers to the Editorial Committee (peer review) and to an evaluator from the Editorial Committee. The manuscript is available from the Editorial Committee's website.

A check list that aids in evaluation is available on the Editorial Committee's website.

The goal is for the evaluation time not to exceed eight days but this may be extended depending on the complexity of the article.

The results of the evaluation, comments and corrections that each evaluator requests from the authors are compiled in the evaluation check list form sent to the authors.

The period of time to make corrections should not exceed eight days but may be extended depending on the complexity of the work. After making the corrections the manuscript is forwarded to the evaluator to decide whether the corrections have been made according to his or her suggestions.

3. Acceptance or rejection.

Following review, the reviewers recommend acceptance or rejection. The editor decides the acceptance or rejection according to the reviewers' observations. The editor may ask authors to clarify aspects as appropriate. The editor may ask for a review of the manuscript by other members of the Editorial Committee or outside experts.

Manuscripts must meet the formal characteristics to be published.

The editor shall email notification of acceptance or rejection for publication.

4. Publication.

The editor shall notify the author by email regarding the article's publication and the literature review.

Ethical responsibilities

- 1. **Conflict of interest.** The manuscript must include a statement that there is no conflict of interest. Any incident should be reported in the evaluation sheet (authorship, reviewers, funding, previous publications on the subject, etc.)
- 2. **In the 56-point Excel check list** that the authors must submit with the manuscript, paragraphs 53-56 relate to conflicts of interest that authors must fill consciously answering yes/no. Reviewers have the same list adapted for evaluation of the manuscript.
- 3. Statement of **sources of financing** if applicable.
- 4. Statement of **sponsorship** if applicable.
- 5. **If the manuscript was previously published in whole or in part by the same authors** this must be noted in the text and bibliographic sources or supports cited to locate the previous work.
- 6. **Original research articles**: must conform to the Biomedical Research Act (Law 14/2007 of 3 July, on Biomedical Research).
- 7. In articles based on **studies with human experimentation** (clinical trials): Certified document from the Ethics Committee of the hospital. For multicentre studies there must be a certified document from each centre.
- 8. **Informed consent.** Photographs that could identify the patient or minors must be accompanied by a document signed by the authors indicating that the documentation has been obtained and published with the consent of the patient or his or her legal representative.
- 9. **Experimentation with animals**. Statement pursuant to Royal Decree 1201/2005 of 10 October, protection of animals used for experimentation and other scientific purposes. The corresponding documentation is included under the appropriate tab (PLANTILLAS) on the journal's website (www.revistaorl.com).
- 10. **Confidentiality**. During the evaluation, acceptance and publication process, the Journal of the Society of Otorhinolaryngology of Castilla y León, Cantabria and La Rioja guarantees confidentiality in handling information. Throughout the process the relationship of the editor and principal authors will be personalized.
- 11. **Plagiarism.** It is considered plagiarism if the manuscript includes text written and published by other authors, without explicit acknowledgment and citation of the source.
- 12. **Procedure in case of plagiarism.** If any of the agents (reviewers, editor) detects plagiarism in the manuscript the following procedure shall apply:
- a. The editor, on behalf of the Editorial Committee, shall provide a substantiated account of the fact to the members of the Editorial Committee.
- b. The editor, on behalf of the Editorial Committee, shall provide a substantiated account of the fact to the first author and/or corresponding author, requesting an explanation.
- c. In case of an already published article a retraction will be requested by the authors.
- d. If plagiarism is confirmed, the editor, on behalf of the Editorial Committee, shall provide a substantiated description of the penalty to the first author and/or corresponding author.
- 13. Penalties in case of plagiarism.
- a. The first author and the corresponding author shall not publish papers in the journal.
- b. This penalty may be extended to other authors of the manuscript if the Editorial Committee deems it appropriate.
- c. Works pending publication in the journal by at least one of the penalized authors will not be published and the first author and/or corresponding author will be notified.
- d. Cases of plagiarism will be reassessed at the annual meeting of the Editorial Committee, which will have capacity to overturn decisions made by the journal's management and specify the length of time of the sanction.
- 14. The Journal of the Castilla y León, Cantabria and La Rioja Otorhinolaryngology Society will adhere to any recommendations or legislation governing scientific communication established by the European Union.
